The undersigned ("Participant") agrees to the terms of this Participation Agreement (the "Agreement"), as well as the terms and conditions stated in the Articles of Incorporation, Bylaws, and Antitrust Guidelines (collectively, the "Organizational Documents") of Media & Entertainment Data Center Alliance, an Idaho nonprofit, mutual benefit corporation ("MEDCA"). Copies of the Organizational Documents are available for review upon request or online at www.MEDCAonline.org/how-to-join. Participant is encouraged to review the Organizational Documents before execution of this Agreement.

Executing this Agreement indicates Participant's request to join the MEDCA organization. This Agreement shall be effective upon acceptance by MEDCA and payment of Participant's initial fee per the selection above and the table below. The initial fee shall be due and payable within thirty (30) days following the acceptance of this Agreement by MEDCA. The fee includes all membership dues as well as participation fees.

This Agreement may be rejected where Participant has selected a Participation Level for which Participant is not qualified per the table above. MEDCA reserves the right in its sole and absolute discretion to deny participation to any person or legal entity if it finds that such participation could compromise the integrity of the MEDCA corporation or its participants, or for the protection of the rights of MEDCA, other participants or other subscribers to the MEDCA service.

The term of Participant's participation shall be on a year-to-year basis, expiring on the day preceding each anniversary of the date of acceptance of this Agreement by MEDCA. The Corporation will invoice the then-current renewal fee to Participant ninety (90) days prior to the expiration of each annual term, and Participant's payment shall constitute a renewal of its participation in MEDCA. Failure to make a timely renewal payment may cause suspension and termination of Participant's participation. The decision to renew shall be at the discretion of the Participant.

Participant agrees that all fees received by MEDCA shall be deemed earned in full and will be nonrefundable except as described in the MEDCA Terms of Use, which are incorporated by reference and applicable to all subscribers of the MEDCA service. By executing this Agreement, Participant also agrees to the MEDCA Terms of Use, which does not need to be signed separately.

For any Level of Participation accepted, MEDCA will generate an invoice for the Participant's first year of Participation fees. Payments may be made payable to the order of "Media & Entertainment Data Center Alliance".
